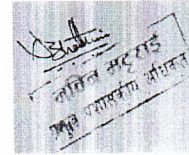

The Pauwadungma Rural Municipality **has allocated funds from GoN, Provincial Government** towards the cost for Upgrading of Tiwaribhanjyang- Mane Dadha- Sano Dumma-Adherighat Road (Panchakanya Krishi Sadak) and intends to apply part of the funds to cover eligible payments under the **Contract Identification** PRM/NCB/Works/079-80/01. Bidding is open to all eligible as per Section V of bidding document..
2. **Pauwadungma Rural Municipality, Bhojpur** invites electronic bids only from eligible bidders for the for Upgrading of Tiwaribhanjyang- Mane Dadha- Sano Dumma-Adherighat Road (Panchakanya Krishi Sadak) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - . Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years : **NRs. 4,50,00,000.00**
 - . Minimum Work experience of similar size and nature : At least one Construction of upgrading of road within the last 10(Ten) years, each with a value of at least **NRs. 1,20,00,000.00.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Pauwadungma Rural Municipality, Bhojpur** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents may be purchased from the office *insert name and* A complete set of bidding documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of **NRs. 5,000.00** for bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Pre-bid meeting shall be held at **Pauwadungma Rural Municipality, Bhojpur** at **13:00 hrs on 2079-05-19**.
7. Electronic bids (one Technical Bid and other Price Bid) must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **12.00 hrs on 2079-05-28**. Bids received after this deadline will be rejected.
8. The Technical bids will be opened electronically in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2079-05-28** at the office of **Pauwadungma Rural Municipality, Bhojpur**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of **NRs. 7,60,000** which shall be valid for 30 days beyond the validity period of the bid.
