Invitation for Bids for the **Construction of Pauwadungma Primary Hospital**

Date of publication: 2077-09-29(Jan 13, 2021)

The Ministry of Health and Population *has allocated funds* from **Federal Government** towards the cost of **Construction of Pauwadungma Primary Hospital** and intends to apply part of the funds to cover eligible payments under the **Contract Identification No:**

PRM/NCB/077-78/01. Bidding is open to all eligible as per Section V of bidding document.

1. **Pauwadungma Rural Municipality, Bhojpur** invites electronic bids only from eligible bidders for the **Construction of Pauwadungma Primary Hospital** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 5,70,00,000.00**
 - Minimum Work experience of similar size and nature: At least one building construction within the last 10(Ten) years, each with a value of at least **NRs. 7,00,00,000.00** that have been successfully or are substantially completed.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Pauwadungma Rural Municipality, Bhojpur** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 4. A complete set of bidding documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of **NRs. 5,000.00**

6. Pre-bid meeting shall be held at **Pauwadungma Rural Municipality, Bhojpur** at **13:00 hrs on 2077-10-20(2nd Feb, 2021)**.
7. Electronic bids (one Technical Bid and other Price Bid) must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12.00 hrs on 2077-10-29(11th Feb, 2021)**. Bids received after this deadline will be rejected.
8. The Technical bids will be opened electronically in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2077-10-29(11th Feb, 2021)** at the office of **Pauwadungma Rural Municipality, Bhojpur**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 17,50,000.00** which shall be valid for 30 days beyond the validity period of the bid .
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
